



Front door to the jail is controlled by several statutes...

- Tex. C.C.P. 15.17 Magistration
- Tex. C.C.P. 17.03 Personal Bonds
- Tex. C.C.P. 17.032 Personal Bonds for MH
- Tex. C.C.P. 16.22 Sandra Bland Act

Providing Defense Counsel at Magistration

- Prior to 2015 Bexar County was making efforts to comply with 17.032 and 16.22
- Out of 11,656 persons with MH issues booked on 125 were diverted
- Provide defense counsel at magistration


Role of Defense Counsel for MH

- Identify persons with MH issues
- Coordinate with clinicians to get assessment and alternatives for treatment
- Communicate with District Attorney on alternatives
- Advocate before the magistrate for release and treatment


Increase in diversions

- Prior to 2015 only 125 persons diverted
- For 2019 on track to divert 630 persons from custody
- Prior to 2015 diverted 2.4 per week
- For 2019 divert 1.72 per day

County Support

 In 2015 three (3) Clinicians and three (3) Assistant Public Defenders

 In 2019 nine (9) Clinicians and nine (9) Assistant Public Defenders

Requirement for Counsel at Magistration?

To conclude, the Court finds that Booth has adequately established a likelihood to prevail under the Sixth Amendment since the Constitution requires representation by counsel at an initial bail-setting hearing.
